Homeowner's Forum: Mr. Ausley expressed his concern for the appearance of the Wedges area. Many homes/yards appear to be in poor condition. He is concerned that this is hurting the property values of the area. He also noted the landscaping crew did not appear to do as well in the fall in cleaning the cul-de-sacs. Mr. Ausley is going to forward a list of the homes he noted of concern to M. Snuggs, N. Peplin and M. Snuggs will then check on the homes noted and report back to the Board.

Mr. Lintelman had several concerns. One was related to real estate info being published in the newsletter. He also had concerns about the relocation of the Greystone sign at Creedmoor. He noted there may be storm water fee rebates if the lakes are designated sediment areas for the City.
